Personally appeared before me, who first being duly sworn, complains and alleges:

COUNT 1

On or about June 26, 2009, in the above named judicial district, the crime of ASSAULT WITH A DEADLY WEAPON, in violation of PENAL CODE SECTION 245(a)(1), a felony, was committed by Krikor Kirk Vartanian, who did willfully and unlawfully commit an assault upon Jane Doe with a deadly weapon, to wit, a Knife.

"NOTICE: Conviction of this offense as a felony will require you to provide two specimens of blood, a saliva sample, right thumbprints, and a full palm print impression of each hand pursuant to Penal Code section 296."

COUNT 2

On or about June 26, 2009, in the above named judicial district, the crime of ASSAULT BY MEANS LIKELY TO PRODUCE GREAT BODILY INJURY, in violation of PENAL CODE SECTION 245(a)(1), a felony, was committed by Krikor Kirk Vartanian, who did willfully and unlawfully commit an assault on Jane Doe by means of force likely to produce great bodily injury.

"NOTICE: Conviction of this offense as a felony will require you to provide two specimens of blood, a saliva sample, right thumbprints, and a full palm print impression of each hand pursuant to Penal Code section 296."

COUNT 3

On or about June 26, 2009, in the above named judicial district, the crime of CORPORAL INJURY TO SPOUSE/COHABITANT/CHILD'S PARENT, in violation of PENAL CODE SECTION 273.5(a), a felony, was committed by Krikor Kirk Vartanian, who did willfully and unlawfully inflict corporal injury resulting in a traumatic condition upon Jane Doe, who was the spouse, former spouse, cohabitant, former cohabitant and the mother or the father of his or her child.

Notice: Pursuant to Evidence Code 1370 it is the People's intention to seek to admit all victim statements to law enforcement if the victim becomes unavailable to testify at trial. Furthermore, pursuant to Evidence Code 1107, it is the People's intention to call an expert witness to testify at trial regarding battered women's syndrome as defined in Evidence Code 1107(a)-(e).

"NOTICE: Conviction of this offense as a felony will require you to provide two specimens of blood, a saliva sample, right thumbprints, and a full palm print impression of each hand pursuant to Penal Code section 296."

COUNT 4

On or about June 26, 2009, in the above named judicial district, the crime of CRIMINAL THREATS, in violation of PENAL CODE SECTION 422, a felony, was committed by Krikor Kirk Vartanian, who did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to Jane Doe, with the specific intent that the statement be taken as a threat. It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to Jane Doe a gravity of purpose and an immediate prospect of execution. It is further alleged that Jane Doe was reasonably in sustained fear of his/her safety and the safety of his/her immediate family.

It is further alleged that in the commission and attempted commission of the above offense, the said defendant(s) Krikor Kirk Vartanian, personally used a deadly and dangerous weapon(s), to wit, Knife, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

COUNT 5

On or about June 26, 2009, in the above named judicial district, the crime of FALSE IMPRISONMENT BY VIOLENCE, in violation of PENAL CODE SECTION 236, a felony, was committed by Krikor Kirk Vartanian, who did unlawfully violate the personal liberty of Jane Doe, said violation being effected by violence, menace, fraud, and deceit.

COUNT 6

On or about June 26, 2009, in the above named judicial district, the crime of DISOBEYING DOMESTIC RELATIONS COURT ORDER, in violation of PENAL CODE SECTION 273.6(a), a misdemeanor, was committed by Krikor Kirk Vartanian, who did knowingly, and intentionally violate a court order obtained pursuant to Family Code section 6218 or Code of Civil Procedure section 527.6 or 527.8.

All of which is contrary to the form, force, and effect of the Statute in such case made and provided, and against the peace and dignity of the people of the State of California.
